Our Mission: To facilitate the cleanup of Bay Harbor without creating additional contamination sites in Northern Michigan!

RESOLUTION: "TO FACILITATE THE CLEANUP AT BAY HARBOR WITHOUT CREATING ADDITIONAL CONTAMINATION SITES IN NORTHERN MICHIGAN."

WHEREAS: Disposal of toxic CKD leachate in a deep disposal well near Alba poses unacceptable risks to our surface and groundwater resources.

WHEREAS: Current disposal methods for CKD leachate do not solve the problems of CKD contamination at Bay Harbor.

WHEREAS: The transport off site of CKD leachate by heavy tankers poses unacceptable risks to surface and groundwater resources, causes undue destruction of roadways, constitutes a traffic hazard and consumes enormous non-renewable energy resources.

WHEREAS: It will take thousands of years to cleanup Bay Harbor based on current methods.

WHEREAS: Recent studies demonstrate that the Dundee Formation is NOT contained and wastes disposed there will migrate to and contaminate surface and groundwater resources.

WHEREAS: The EPA ordered CMS to "Remove, Isolate or Contain" the CKD wastes at Bay Harbor.

WHEREAS: Significant volumes of highly caustic CKD leachate continue to breach past the high maintenance collection system installed at Bay Harbor.

WHEREAS: The true long-term costs, risks and liabilities for the current disposal methods have NEVER been fully factored.

WHEREAS: It is irresponsible to pass on the cleanup of Bay Harbor to future generations.

WHEREAS: Entombment of CKD at Bay Harbor in impervious cells may be one of several alternatives to deep well disposal that isolates, contains and actually solves the problems of environmental contamination and risks to public health in a safe, timely and cost effective manner.

BE IT THEREFORE RESOLVED THAT WE THE UNDERSIGNED DECLARE:
"WE SUPPORT THE FRIENDS OF THE JORDAN AND THE P.O.W.E.R. COALITION IN THEIR RIGOROUS EFFORTS TO DENY THE ALBA WELL & ENFORCE THE ORIGINAL EPA ORDER OF ISOLATION AND CONTAINMENT OF CKD AT BAY HARBOR."
